- 6a. Teen pregnancy rates continue to climb in Tennessee and elsewhere, primarily out of wedlock. As an elected legislator, how would you propose to deal with this difficult social problem and its demands on public funds?

Teen pregnancy is undoubtedly a serious issue in Tennessee and across the nation. In my view, families and communities and churches and other local organizations can still have the most powerful positive influences on our nation's young people, and I believe these groups should continue to take steps that will prevent many teen pregnancies from occurring in the first place. When problems do occur, these groups, along with local and state governments, should stand ready to assist those in need.

From a federal perspective, I am encouraged that the welfare bill recently enacted into law includes a provision denying cash aid to unmarried mothers under age 18 and their children unless they live with an adult relative or in an adult-supervised arrangement. The law also requires states to provide or assist unwed minor mothers in finding a suitable home, maternity home, or other appropriate adult-supervised living arrangement. If the mother has not completed high school, the law requires her to attend school or an approved alternate training program once her youngest child is 12 weeks old.

- 7. Should Congress/legislature be setting standards that limit medical procedures deemed necessary by physicians?

I recently supported legislation that would prohibit health insurance companies from forcing mothers and their newborn children out of the hospital after as little as 24 hours. I do not believe that insurance companies should have the power to overrule a physician's determination of what medical treatment is necessary for a woman after she gives birth. Decisions about when a new mother goes home from the hospital should be made by a doctor and the mother, not by an insurance company employee.

8. Please summarize your personal philosophy on the issue of reproductive choice

The Supreme Court has attempted to delineate the constitutionally appropriate roles for individual and governmental decision-making on the issue of abortion. Beyond that, I believe that the federal government should not interfere with individual convictions and actions in this area.

I would make an exception to this general rule of governmental non-interference in a very limited number of cases where government has a compelling interest in promoting the public welfare. For instance, I believe that states should be allowed to impose various restrictions (i.e. parental notification, 24-hour waiting periods, etc.) if they so choose.
